- 2. Pet(s) will not cause: danger, damage, nuisance, noise,health hazard or soil the house/condo/townhouse/apartment/unit, premises, grounds, common area, walk, parking area, landscaping or gardens. Tenants agree to clean up after the pet and agree to accept full responsibility and liability for any damage, injury or actions arising from or caused by the pet(s).

 Seeds and dropping will be shielded or caught to prevent accumulation and/or damage to carpeting/floors.
 - FISH Aquariums will be cleaned frequently to prevent foul water and/or odors. Tank will need to check for leak when cleaning.
 - **REPTILES/SPIDERS** Must be caged at all time and not permitted to be let loose at anytime.
 - EXOTIC ANIMALS Will not be permitted under any circumstances due to state, city and local regulations
